



Road use charge, goods transport Hungary

Vignette system

Vehicle categories and tariffs are as follows:

Category D1: vehicles or combinations up to 3.5t MPW - these vehicles have to pay road use charge on motorways.

Category D2: vehicles or combinations over 3.5t to 7.5t MPW - these vehicles have to pay a road use charge on motorways, trunk roads and certain main roads.

Category D3: vehicles or combinations over 7.5t to 12t MPW - these vehicles have to pay a road use charge on motorways, trunk roads and certain main roads.

Category D4: vehicles or combinations of over 12t MPW - these vehicles have to pay a road use charge on motorways, trunk roads and certain main roads.

The MPW taken into consideration is based on the value indicated in the registration document.

E-vignette

As of 1 July 2013, the electronic, distance-based toll system (DTS) has been introduced on a total of 7,000 km designated road sections of the Hungarian public road network (motorways, highways, main routes).

The new system will comply with the European Union requirements and the directives of the European Electronic Toll Service (EETS) (Act LXVII of 2013 on distance-based toll payable for the use of motorways, highways and main routes). The rate of distance-based toll payment depends on the used road type, the category of the motor vehicle >> (J2, J3, J4), as well as its environmental classification.

Starting from 15th of March 2020 the toll rates will increase with 3.4 % in every category, compared with the actual prices.

Vehicle categories and tariffs are as follows:

Category J2: Heavy goods vehicle with a total weight over 3.5 tons with two axles

Category J3: Heavy goods vehicle with a total weight over 3.5 tons with three axles

Category J4: Heavy goods vehicle with a total weight over 3.5 tons with four or more axles
